Division of HIV Disease Updates

Care Program

- Staffing:
 - Joanne Valentino has retired. Please send all HOPWA questions to Moira Foster <u>mofoster@pa.gov</u> and Rob Smith <u>rofsmit@pa.gov</u>.
 - The Program terms Report and Progress Report were both submitted to HRSA in July.
 - The Notice of Funding Opportunity for the Ryan White Part B Grant has been released. The application is due November 8, 2021. This is the full grant application which is required every 5 years.
 - We are in the process of starting a Case Management Workgroup.
 Participants are being notified and the first meeting date will be set.
- CAREWare:
 - CAREWare centralization is currently underway
 - If there is interest, the Division will provide general CAREWARE training to those who request it
- CQM:
 - CQM Plan Review Checklist-1st step in the development of the 2022
 CQM Plan. CQM Plan Review Checklist was reviewed and completed by the CQM Workgroup. A copy of this document will be posted on the Regional Grantee SharePoint as well as provided to HPG.
 - CQM Plan Policy-this will be posted on the Regional Grantee SharePoint and provided to HPG.
 - The 2022 CQM Plan will be based off 1/1/2021-8/31/2021.
 - a. Our DOH data team will develop a data report identifying a list of unique client service category utilization, which will indicate the service categories required to have performance measures.

- b. To the extent possible, please encourage providers to submit the August monthly CAREWare PDE by 9/8/2021.
- CQM Plan
 - a. CQM Workgroup and DOH staff will review CQM Plan draft and provide feedback. CQM Plan draft will be reconciled and submitted for DOH formal approval.
 - b. Upon approval, the 2022 CQM Plan will be presented to HPG and posted on the Regional Grantee SharePoint. A "save the date" was sent for a 2022 CQM Plan review in December 2021.
- Data Visualization Reports
 - a. 2nd quarter Data Visualization Report reviews will be scheduled for the 1st week in September (to the extent possible).

Monitoring and Evaluation

- DOH will continue to do regional annual site visits until the end of the year. DOH will allow the regions to do virtual site visits with providers at least till the end of the year. Regions can choose to do in person visits, but we are not requiring it. DOH's in person monitoring visits may resume after 2021, if all entities agree.
- None of the monitoring tools have changed for the current round of site monitoring. Guidance that was issued earlier this year goes into effect July 1, 2021 and does not impact this year's monitoring visits. The guidance will be applied for the next round of site visits.
- It's an expectation to review charts if at all possible, but chart reviews can be waived until in-person site visits resume. Once in-person site visits resume, DOH will request that selected charts from the last 12 months be included in the monitoring.
- The time and effort guidance are being finalized and will be made available to the Regions next week.

 - New generic HIV treatment meds added
 - EMTRICITABINE-TENOFOVIR DISOPROXIL FUMARATE (Truvada)
 - EFAVIRENZ-EMTRICITABINE-TENOFOVIR DISOPROXIL FUMARATE (Atripla)
 - In addition, several other brand and generic meds were also added to the formulary
 - Pharmacy Network list updated 7/1/21
- Medicaid back-billing
 - Manual void/rebill process with pharmacies
 - 3rd cycle of recoveries is in process
 - Recovery process will continue to occur quarterly
- Medication adherence pilot update
 - 31 prescriber's offices were identified for conducting outreach to
 - o 650 clients who were identified as non-adherent on HIV medications
 - Consultations with 20 of the 31 prescribers have been completed
 - So far 345 clients were addressed through consultations.
 - 12 clients were identified for additional ongoing case management
 - Pilot project will be ending in July and data will be compiled to assess the outcomes of the pilot.
- Next SPBP Advisory Council Meeting will be held Thursday, October 28, 2021 – 10:00 a.m., conference call or in-person meeting still to be determined


